

**TARSUS UNIVERSITY**  
**2021 ACADEMIC YEAR**  
**ACCEPTANCE AND ASSESSMENT CRITERIA OF FOREIGN STUDENTS**

It has been unanimously decided that the admission and registration procedures will be carried out as follows after the evaluation of the applications of the candidates who want to study within the scope of the International Student Program in the 2021-2022 academic year.

1) Regarding the Admission of Students from Abroad to Associate Degree and Undergraduate Programs of Our University It was determined in accordance with Article 7 of the Principles and by the Presidency of the Council of Higher Education. Applications for the approved quotas for 2021 will be received electronically.

2) Among the applicants, those who meet the conditions specified in the Criteria for Accepting Students from Abroad as determined by the Turkish Council of Higher Education and the conditions specified in Article 6 of the Principles Regarding the Acceptance of Foreign Students to Tarsus University Associate and Undergraduate Programs will be accepted.

3) Evaluation procedures of the candidates whose applications are accepted Pursuant to Article 9 of the Principles Regarding the Admission of Students from Abroad to their Programs, and The following principles have been determined by the Overseas Student Admission and Evaluation Commission:

a) A maximum of 5 (five) preferences from the Programs in which the candidates want to be placed at our University will be taken into consideration.

b) in placement procedures; Candidates who will choose the Faculty and Vocational School Programs of our University should get at least 90 points from the YÖS exam held by Turkish State Universities at the time of application, and at least 85 points for those who will prefer Faculties.

c) In backup placement operations; Candidates who will choose the Faculty and Vocational School Programs of our University should get at least 85points from the YÖS exam held by Turkish State Universities at the time of application, and at least 80 points for those who will prefer Faculties.

d) They are required to get 1000 points or more from the GRE, GMAT, SAT, ABITUR exams approved by the Higher Education Council of Turkey, and 500 or more points for the ABITUR exam.

e) Placement procedures will be done with the "Foreign Student Exam-YÖS" held by Turkish State Universities, and the vacant quotas will be evaluated according to other exam types specified in item c.

f) The score of the type of exam applied through our Commission for Placements in the Program, and will be made in order of preference from highest to lowest.

g) In the placement process to the announced quotas of the programs, cultural A maximum of 50% from the same country to the same program for the purpose of increasing diversity students will be placed A fractional result of the quota as a result of the calculation made If the value after the decimal point is 5 or more, then the next integer, if less than 5, the previous rounded to integers.

4) The final registration procedures of the candidates with the receipt of the applications will be made by Student Affairs Department
